Candace advised it was an interesting meeting with a busy agenda. Mario Salituro was returned as President after a year's absence and Mark Bell was elected as Vice-President. This should bode well for KYSA as it attempts to have the KSRA and its members address some issues that have been brought to the KSRA's attention over the past few years.

Candace was also pleased to be invited to the staff Christmas lunch on December 15 at the Sandbar Grill on Tranquille.

Vice-President - Rod Gurnsey:

Rod also commented on the recent KSRA AGM, noting it was an "eye opener" for him having never attended one of their meetings before. It was noted the KSRA is not a registered charity and does not have an independent audit of its finances. Furthermore, the association is not currently affiliated with BC Soccer or the BC Soccer Referees Association.

While in Salmon Arm Rod had the opportunity to speak with Kevin Harrison, the Executive Director of the Shuswap YSA, about a number of things: Shuswap currently registers around 1100 players. The district receives around \$65,000 annually from gaming grants which is put toward salaries.
